**Full Paper Submission Guidelines:**

- i. The paper must be an original contribution of the author and must not have been published before or is not being considered or in the process for publication elsewhere. While submitting the paper, the author has to specify the sub-theme. The name, affiliation and contact number of the author (or authors) must be included at the top of the paper between Title and Abstract.
- ii. The paper must demonstrate sound research principles and include complete and adequate referencing in accordance with APA style.
- iii. The paper must be within the range of 3,000 and 4,500 words (excluding title and author details). The full paper must be submitted in MS Word file format (.doc or .docx) with the following specifications-
  - a. Font Style: Times New Roman
  - b. Font Size: 12
  - c. Line Spacing: 1.5
  - d. Page Set up: A4 Size

In case of a paper containing tables and figures, the author must also submit the paper in PDF Format along with the MS Word file.

- iv. For publication of full paper in the Conference Proceeding, the authors have to register themselves within the stipulated date of registration. In case of a paper contributed by more than one author, all the authors of that paper must register individually.
- v. The authors need to maintain a strict ethical stand regarding acknowledgement of works cited and ideas borrowed from others. All papers shall be subjected to mandatory plagiarism check. The decision of the concerned committee of the International Conference will be final in this regard.
- vi. All papers should be submitted by email at **fullpaperic2019@kkhsou.in** on or before **5<sup>th</sup> September, 2019**.
- vii. Authors are suggested to register for participation in the International Conference only after receiving the confirmation of the acceptance of their full papers.

**Full Paper Review Process for Acceptance:**

All papers shall go through blind peer review by reviewers selected by the concerned committee of the International Conference. The acceptance of full papers shall be based on the following criteria:

- The paper is related to one of the sub-themes, and is based on sound argument and analysis.
- The significance, applicability and relevance to the field is clearly articulated.
- The problem is clearly described within a theoretical framework (where appropriate).
- The literature review (where necessary) needs to reflect a clear relationship between the problem selected and Open and Distance Learning/ Livelihood Issues in the Developing Countries.
- The research design and methodology are appropriate for the study and the discussion of the results is accurate and useful.

The author (in case of more than one author, the corresponding author) will be notified about the results of the review by 15<sup>th</sup> October, 2019. Immediately after receiving of acceptance note, the authors are required to register for the conference as per the modalities outlined in the conference website. However, to ensure publication of the full paper in the conference edited volume, the authors are requested to address the comments and recommendations of the reviewers if any for improvement of the paper.
